- ❖ 82.1% of persons without disabilities aged 18 to 64 are employed.³
- ❖ 46.0% of PwDs aged 18 to 64 are employed.³
- ❖ 16,400 persons aged 16 to 20 have a disability.¹
- ❖ 266,400 persons aged 21 to 64 have a disability.¹
- ❖ 57,000 PwDs aged 18 to 64 receive benefits.¹
- ❖ In 2012, MN's total expenditure on SSDI benefits was \$1,837,896,000.³
- ❖ Voc. Rehab. received 241 blind applicants and 8,004 general applicants in MN in 2012.³
- ❖ Voc. Rehab. obtained 2,571 jobs for PwDs in MN in 2012.³

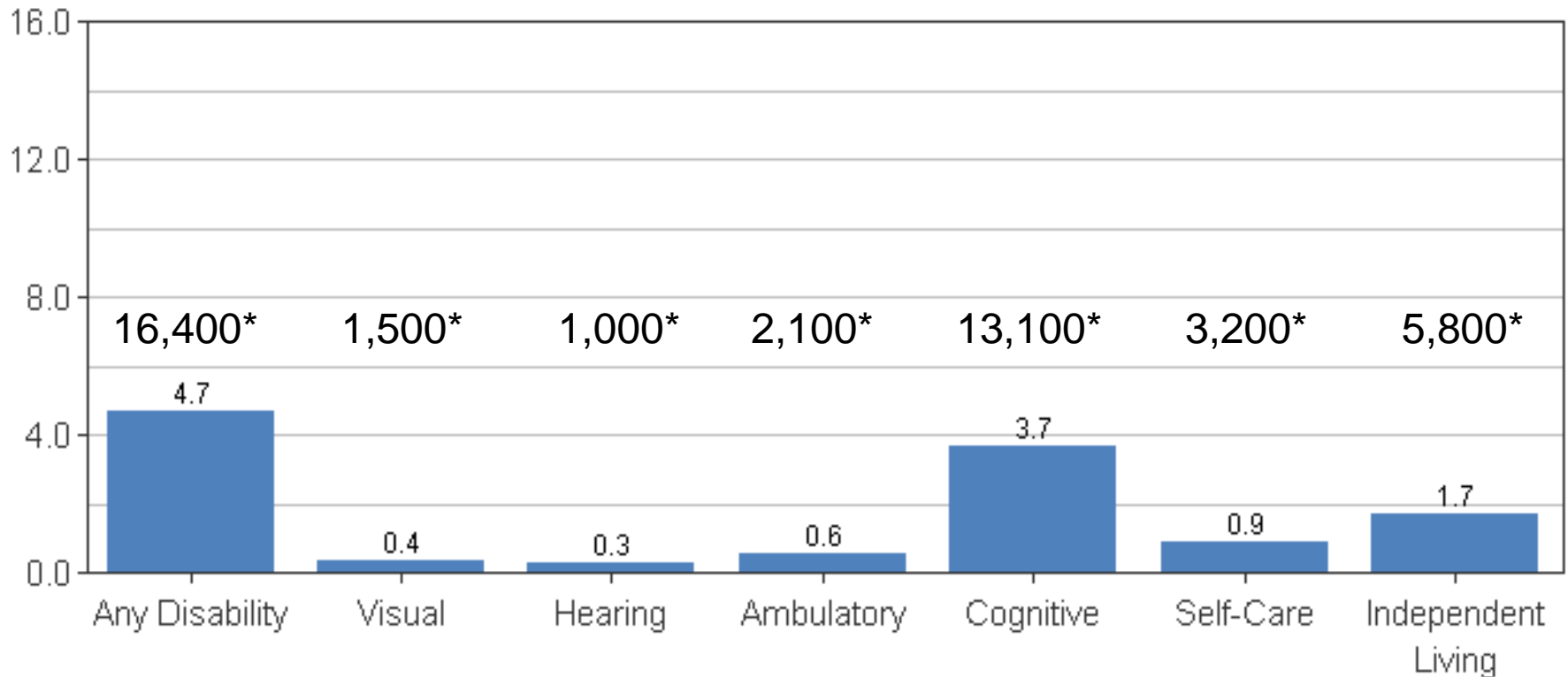

Prevalence Rates: Age 16 to 20 years (%)

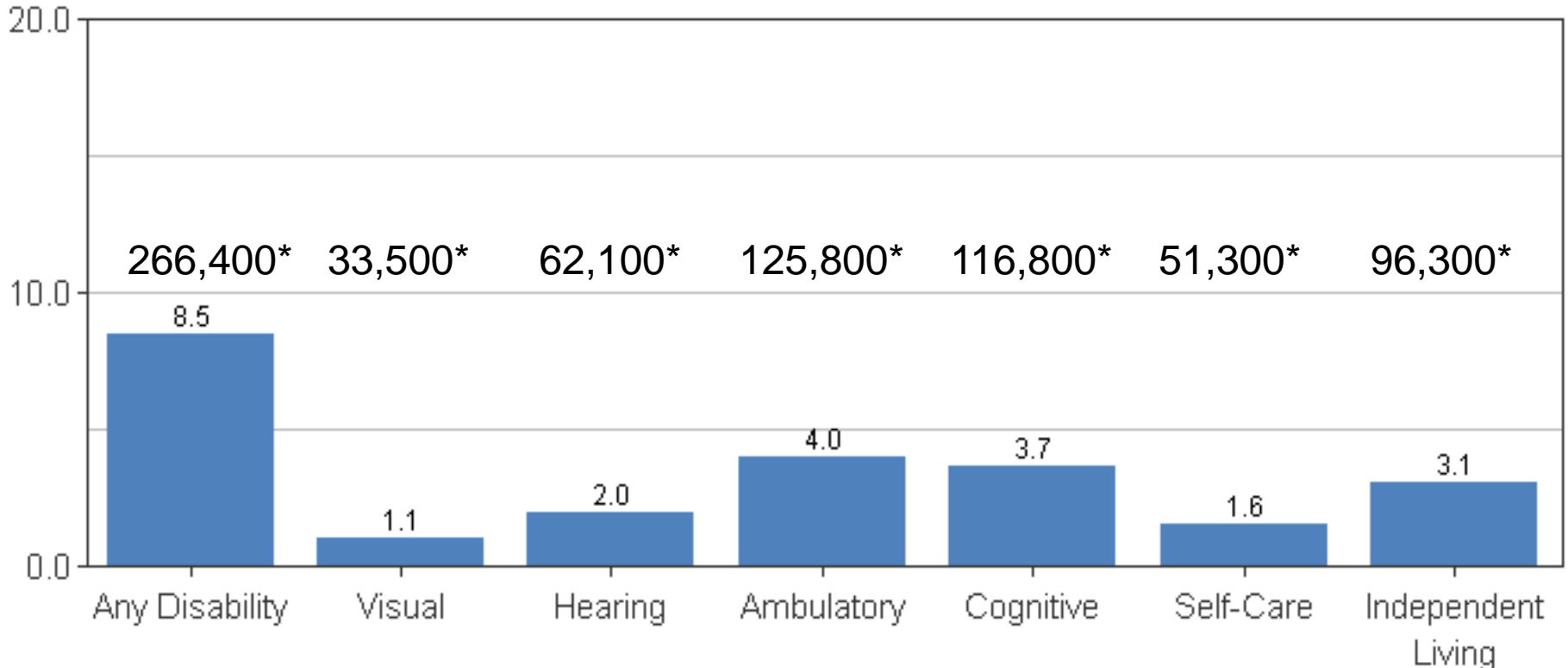

Prevalence of Disability Among Non-Institutionalized People Ages 21 to 64 in Minnesota in 2012

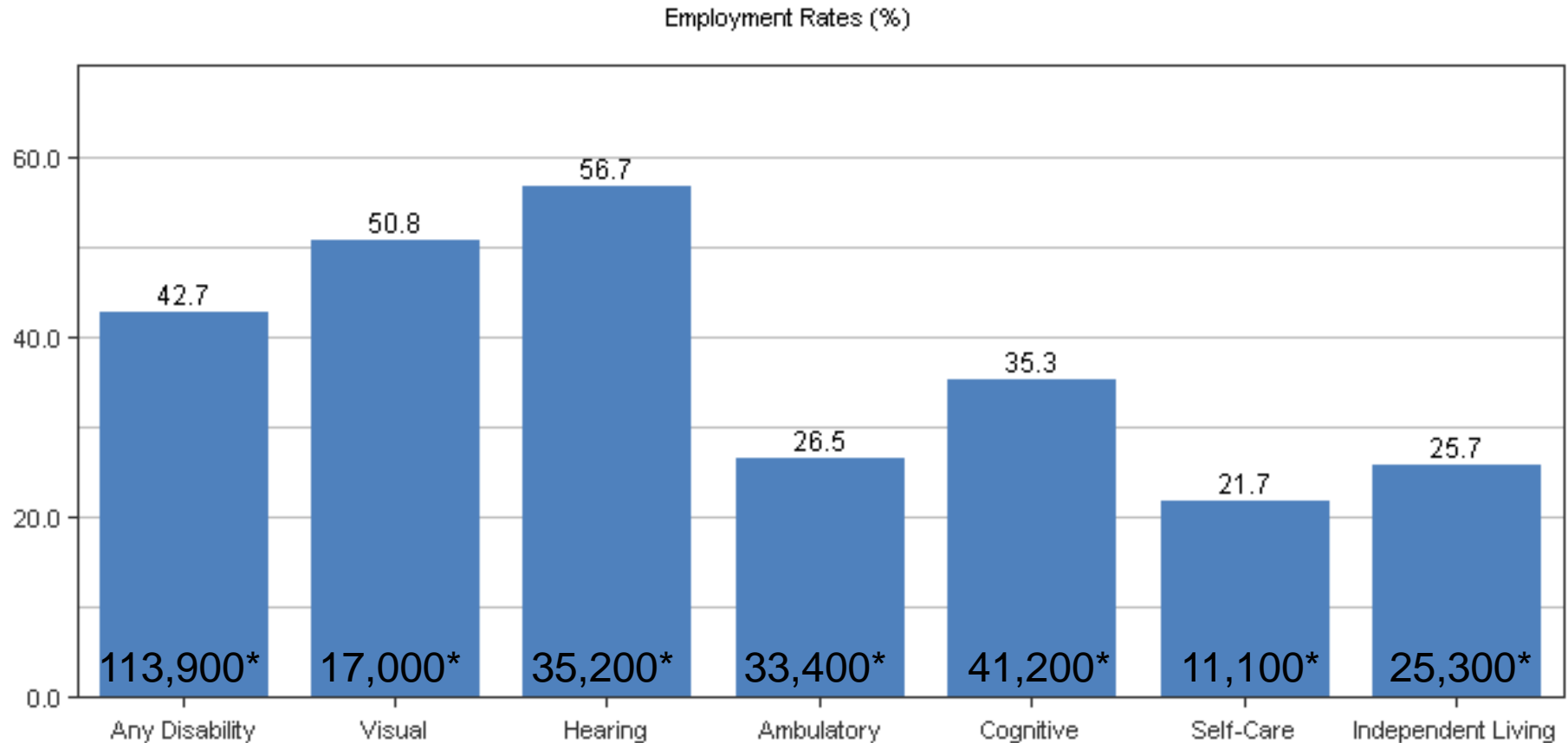
Prevalence Rates: Age 21 to 64 years (%)
